Observer Status in the Parliament

Organizations can apply to the Secretary of the Parliament for the observer status to attend and observe parliamentary sessions, plenary debates, committee meetings, or public hearings that are relevant to their area of expertise (e.g., environment, health, human rights).

Consultative Status in the Parliament

Organizations can apply to the Secretary of the Parliament for consultative status at either the parliament level or the level of a specific committee or commission, depending on their area of expertise. This status enables organizations to actively engage with parliamentary bodies by providing expert input, submitting reports, or participating in hearings.

These roles allow organizations to influence policy, provide expert input, and contribute to the legislative process. The application requires demonstration of expertise and relevance to the parliament or commission/committee's work.
